Z-ROCK 103'S "TICKETS FOR A YEAR 2024" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WXZZ ("Station"), owned and operated by Cumulus Broadcasting LLC, 300 W. Vine St Ste 300, Lexington, KY 40507, during available business hours Monday through Friday, on Station's website www.zrock103.com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **Z-Rock 103's "Tickets for A Year 2024"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last **24 hours** or a prize valued at \$500 or more in the **calendar year 2024** and whose immediate family members or household members have not won a prize from the Station in the last **24 hours** or a prize valued at \$500 or more in the **calendar year 2024** and whose immediate family members or household members have not won a prize from the Station in the last **24 hours** or a prize valued at \$500 or more in the **calendar year 2024**. **Void where prohibited by law.** Employees of **Cumulus Broadcasting LLC**, Station, each of its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and stepsiblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest will begin at 12:01am ET on April 1st, 2024 and will run through 11:59pm ET on June 14th, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

Listen to the Station weekdays from 6am - 10am during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 859-280-1033. Caller 13 to the Station, as determined by the Station in its sole discretion, will be entered to win. <u>*Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- 4. **Winner Selection.** On or about 10:00am ET on June 17th, 2024, Station will select forty-four (44) entries for standard prize in a random drawing from among all valid entries received by Station during the Contest Period. Standard prize winners will be placed into a separate drawing for the grand prize. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
- 5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING

IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

The Prize is a pair of tickets chosen by Station at its sole discretion. **Approximate Retail Value of the Prize is ONE HUNDRED TWENTY DOLLARS (\$120).** Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

(ii) Grand Prize. One (1) grand prize ("Grand Prize") will be awarded in this Contest. The Grand Prize is a pair of tickets each month starting in June 2023 and ending in May of 2024. The winner will get a list of a few shows each month that they can choose as their pair of tickets for that month. In total, they will have 12 shows and 12 pairs of tickets from June 2023-May 2024. If they would like to skip a month, the next month they will be able to choose an extra pair of tickets. Approximate Retail Value of the Grand Prize is ONE THOUSAND FOUR HUNDRED AND FORTY DOLLARS (\$1,440). Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the Grand Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

If any concert is temporarily postponed or permanently cancelled due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Cumulus Broadcasting LLC or the Station, then no substitution shall be provided by Cumulus Broadcasting LLC or the Station. Neither Cumulus Broadcasting LLC nor the Station make any representation or warranty about the safety of the concert in light of COVID-19. By accepting the Prize, a winner acknowledges the risk of large group gatherings and assume all risks of accepting the Prize, attending the concert and any other risks associated with the concert, including any and all repercussions associated with attending the event.

7. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Broadcasting LLC, Cumulus Media New Holdings, Inc., and each of their respective subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling,

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.
